UEFA Minimum Health & Hygiene Requirements for the Return of Spectators

WE CARE ABOUT FOOTBALL

MINIMUM HEALTH AND HYGIENE REQUIRMENTS – KEY POINTS



- Decision to admit spectators is for the local authorities;
- If spectators are allowed, UEFA permits up to 30% of the capacity to be used;
- Local authorities may decide to impose a lower limit but not a higher one;
- Declaration of compliance with the minimum requirements to be submitted to UEFA;
- Match schedules will not be altered due to decision to allow, or not, spectators to attend.

RETURN OF SPECTATORS – KEY POINTS //1

- Comprehensive plan must be prepared;
- Ticketing;
 - Ticket holder obligations;
 - Tickets must be personalised;
- Seat allocations;
 - Unassigned seats to be fixed in closed position or marked;
- Queue management system (entry, concessions, toilets, etc.)



RETURN OF SPECTATORS – KEY POINTS //2

Hygiene;

- 1m distances (WHO recommendation) as a minimum;
- Clean and disinfect all areas;
- Install hand sanitizers;
- Spectators and staff to wear masks;



Protection of Zone 1 and 2 staff;

- 4.5m between spectators and zone 1 and 2 staff (i.e. team benches, camera positions);



Communication strategy to supporters;

- Travel, distancing, ticketing, etc.
- Announcements, signage, stewarding, etc.
